50 hours of law-related pro bono work as defined and required by § 52016 of the Rules of the Court of Appeals prior to being admitted Applicant must submit a form affidavit for each pro bono project that applicant is using to satisfy the 50-hour requirement and must secure the certification of the individual who supervised each project
